THE AREAS OF CONSERVED PROPERTY INCLUDE, BUT ARE NOT LIMITED TO, THE TOWNS OF PHILIPSTOWN, FISHKILL, PUTNAM VALLEY, AND CORNWALL, NY. WE HAVE ALSO HELPED OTHER LAND TRUSTS AND STATE AGENCIES CONSERVE THOUSANDS MORE ACRES. FURTHER, HHLT ALSO FOUNDED AND COORDINATES THE "NEW YORK HIGHLANDS NETWORK"
